The Church/Ministries in its application for a Church/Ministries Charter from the Fountain of Life Outreach Ministries Inc. agree to support the Fountain of Life Outreach Ministries Inc. for gifts and offerings to its various ministries schools in missions program. Also the Fountain of Life Outreach Ministries Inc. will except electronic checking with debit card Visa, MasterCard, and Discover card.

The yearly accounting period for all subordinate must end on December 31. A notarized copy of your Annual Church Financial Report, (this form is mailed to you from F.O.L.O.M.I. International Headquarter) and your Annual renewal fee of \$150.00 will renew your church membership as long as the Church/Ministries charter remain in good standings with the Fountain of Life Outreach Ministries Inc. and meets the above requirements.

The Church/Ministries upon approval by the Fountain of Life Outreach Ministries Inc. for church charter shall remain at all times a sovereign Church/Ministry and comply with all City State and Federal Regulations together with any other local and otherwise agency that maintain a governing control over the Church/Ministries compliance with said ordinance, law, and control shall be at all times the responsibility of the Church/Ministries.

This Church/Ministries agree to hold harmless and indemnify the Fountain of Life Outreach Ministries Inc. its officers, representatives, employees, staff, fellow members and assigns from any and all damage, suits liabilities or criminal actions intentional or otherwise that may arise as a direct or indirect result of any member. Minister, Clergy, Pastor or Bishop during or following any church meeting, counseling or accident, all of whatever kind or nature, regardless of the proximity to or relationship with the Church/Ministries.

Any violation of the above said agreement by subordinate shall result in the dismissal of the Church/Ministries Charter granted by the Fountain of Life Outreach Ministries Inc.

Article I

The Name of this Organization shall be

Article II

This organization is a nonprofit organization. The purpose of this organization is to engage exclusively in religious, charitable and educational purposes within the means of section 501 (c) (3) of the Internal Revenue Code of the United States of America. This organization is not to be operated for the benefit of any individual, but rather for the public interest and out of a desire to manifest and cultivate faith in our Lord and Savior Jesus Christ.

Article III

This organization is to have a perpetual duration. However, should this organization for any reason be dissolved, then in that event the assets of the organization may only be used for religious, charitable and educational purposes within the means of section 501 (c) (3) of the Internal Revenue Code of United States of America.

Article IV

The address of this organization shall be _____ in the County of _____, in the state of _____

Article V

This organization shall generally possess all power rights, privileges, capacities, and immunities which nonprofit organizations authorized, and may hereafter be authorized according to the laws of this State, to borrow money, to collect, to sue, to be sued, to receive, to take hold, lease, purchase, improve, sell, mortgage, or otherwise dispose of personal, real or mixed properties in any such manner permitted by law to the end that the purpose herein set out may be promptly accomplished, and to receive by donation or otherwise any sum of money, goods, or real property which any person or persons, firm or corporation should see fit to donate to this organization.

Article VI

The power in management of this organization shall be vested in an exercise by a board of directors of not less than five(5) members but only two (2) of its members may be blood related to the one another. Article VII

Executive officer of this organization shall consist of the Pastor/President, a Secretary, a Treasure and such other officers as board of directors may elect an appoint. The Pastor/President, the Secretary, and Treasure are to be elected by unanimous vote of the Board of Directors and is to serve until removed or into their successor a duly elected and installed.

Article VIII

Notwithstanding any other provisions of these Articles, this organization shall not carry on any activity not permitted to be carried on by an organization exempt from Federal Income Tax under section 501 (c)(3) of the Internal Revenue Code of 1986.

Article IX

The voting membership of this organization shall consist of the persons named above as directors, and of all persons who shall meet the following qualifications for voting memberships and who shall be admitted in a manner hereinafter set forth:

1. In order to qualify for voting memberships, a prospective member must accept, belief in and rely all on the Lord Jesus Christ for his or her salvation.
2. Must believe that the holy Bible is inert and the word of the living God.
3. Must confess his/her faith in Jesus as Lord and Savior and give evidence of his/her intention to keep and follow his commandments.
4. Must commit himself/herself to participating actively in the organization.
5. Must submit himself/herself to the Authority of the officers and the Board of Directors
6. Must subscribe to the purpose of the organization.
7. Board of Directors shall determine whether any applicant requesting voting membership meets the foregoing qualifications and if so, the advocate may be admitted as a member of the organization.

Article X

The membership of the Board of Directors and Executive Officers shall consist of persons who meet the following additional qualifications.

- Believe in and must practice the doctrine statement of the Fountain of Life Outreach Ministries Inc.
- Furthermore a candidate must agree to, submit to, abide by the Code of Ethics and Doctrine Statement of the Fountain of Life Outreach Ministries Inc.
